## ONLINE TRAINING PROGRAMME - FEEDBACK BY TRAINEES - GROUP 1

At the end of the first training session, that was held from the 27<sup>th</sup> of February to the 24<sup>th</sup> of March 2026, the young participants were asked to express their opinions on the training contents and organization, relational aspects and the trainers (Nikoleta Đukanović and Francesco Emanuele Celentano).

Concerning the **trainers**, the majority of trainees responded that they were clear in the explanation of the training contents, were able to get participants involved during the training sessions and helped participants in understanding contents which they were not familiar with.

Concerning the **training contents**, the majority of trainees replied that they were interesting and satisfied their expectations.

Concerning **relational aspects**, the majority of trainees declared that they had the chance to establish new and nourishing relationships and that they felt enriched by the experience

Concerning the **organization** of the training sessions, most of the trainees appreciated the time schedule and believed that the training programme was communicated and promoted in an effective way
